New Breath Foundation (NBF) mobilizes resources to support Asian American and Pacific Islanders (AAPIs) to heal, keep families together, and build movements that shift narratives and policies.

2020 **SO FAR**

COVID-19 RESPONSE

Currently and formerly incarcerated communities are among the most impacted by COVID-19. San Quentin has had 2,200 cases of COVID-19 and 25 deaths, out of a population of 3,260. The coronavirus has also hit post-incarceration and transitional homes in the Bay Area very hard.

In response to this and other COVID-19 related crises, NBF and our partners are ensuring the health and safety of our communities through direct payments, grassroots actions and donating supplies.

Insight Garden Program, NBF, and other partners donated much-needed soap to 2,700 incarcerated people in Central California Women's Facility, and NBF donated Personal Protective Equipment (PPE) to Asian Health Services in Oakland Chinatown.

NBF and our partners urgently called for the release of people detained and incarcerated to stop preventable deaths from COVID-19. We funded organizing campaigns for releases, pardons, and commutations for immuno-compromised individuals, women, trans folks, lifers, and people at risk of deportation. Led by grassroots organizations, NBF has supported protests, rallies, social media actions, petitions, phone call actions, and advocacy to release more people from

state prisons and jails who are at high risk for COVID-19. The California Department of Corrections and Rehabilitation (CDCR) estimates that about 8,000 people were released by the end of August. It is a unique and unprecedented moment to advocate for the mass releases of incarcerated people on the basis of public health and decriminalization priorities and NBF will continue to play an integral role in this fight.

RACIAL SOLIDARITY

NBF President Eddy Zheng plays a critical role in bridging communities, especially formerly incarcerated, Black, Asian, immigrants, and refugees. Eddy's role includes speaking to the media (English and Chinese languages), exploring restorative justice methods as an alternative to incarceration, and building strong coalitions with community leaders, elected officials, and philanthropic leaders. As a trusted and outspoken champion for racial solidarity, Eddy has answered the calls of many community leaders for his assistance in creating innovative, systemic change. Eddy sits on the newly-formed SF Coalition for Community Safety and Justice to ensure public safety, culturally-competent victim services, and healing through systemic change and new programs.

NBF has drawn attention to the 800+ hate incidents related to COVID-19 targeting Asian Americans in California to date. We will continue to engage in community-led strategies for healing and racial solidarity.

2020 IMPACT Sole's STORY

Last November, NBF coordinated a Listening Tour in Cambodia with intentionally selected partner organizations who could launch an innovative Right2Reunite solution.

We had heard stories of deportees (DPs) who would likely be able to return home. But we didn't expect to meet Sok Khoeun Loeun. Sok drove five hours to see us to share his story about opting out of ICE detention and selfdeporting, leaving 3 children as a single father with his mom.

Sok held on to a glimmer of hope that he could return to the US.



When he heard Sok's story, attorney Anoop Prasad from Advancing Justice Asian Law Caucus worked quickly to get Sok's official records and discovered that he was not deportable. Sok was a US Citizen!

And within three months of our group's return to the US, Sok - after being in Cambodia for 5 years - was reunited with his US family.

2020-2021 PRIORITIES

Infrastructure Development

Still in our nascent developmental stages, NBF will continue to strengthen our internal infrastructure over the next 12 months through a number of projects, including:

- Board recruitment and development
- Strategic plan and theory of change
- Development of a communications and fundraising strategy
- Human Resources policies
- Refinement of staffing structure and
- Finance and accounting policy improvements

These six areas of infrastructure development will ensure NBF's mission and programs are protected and strengthened.

Transforming Philanthropy

NBF stands in the gap created by traditional philanthropy which has marginalized AAPI leadership and directed less than 1% of funding to our communities. We are also guided by our commitment to inspiring women, immigrants, refugees and the formerly incarcerated to lead. NBF values the lived experiences of impacted communities in solving problems. And we support organizations that create space for impacted people to lead.

Grantmaking

NBF established three grants programs: Hope and Healing, Keep Families Together and Movement Building. We've launched our third round of grant making and will complete distributions before the end of October. The NBF team has engaged 13 community organizations for this cycle. NBF will make grants according to the following priorities.

- COVID-19 impacts on currently and formerly incarcerated communities
- Racial justice
- Anti-deportation
- Mental health of deportees
- Decarceration, alternatives to incarceration

Additionally, NBF will support community organizations that ensure the rights of monolingual Chinese families as they navigate the foster care system and reunite with their families.

At this time, NBF distributes grants by invitation only. With additional funding we will move to open requests for proposals.
